The scope of this VPAT is limited to the Chrome OS software and does not apply directly to hardware devices. Please refer to the VPAT for the specific Chromebook models for additional details.

4. Settings
5. Files
6. Chrome Browser

The following features are considered experimental and are not available on all Chrome OS devices, and are therefore outside of the scope of this document:

1. Google Play Store
2. Linux shell
